Study abroad students studying for a full school year may be able to undertake the Victorian Certificate of Education (VCE) Vocational Education and Training (VET) subjects, depending on their year level. VET subjects may incur additional tuition fees ranging from \$49 to \$1,739 per subject, per annum. In addition, VET non-tuition material fees ranging from \$90 to \$950 per subject, per annum may be applicable. All fees are reviewed annually and are subject to change. VET fees are not reflected in the estimated course tuition fees above. The school will inform the student and their family of any additional VET fees before the student commences a VET subject.
